The businesses are supported by a combined team of 34 employees, including an experienced General Superintendent, 4 Foreman, an Office Manager plus CDL drivers, and equipment operators. The seller is preparing for retirement and has offered a transition period of up to one year to ensure continuity of operations and relationships. Additionally, the seller has offered to carry 15% of the purchase price as a show of good faith in the continued success of the business moving forward. This deal comes with over \$2,000,000 in working capital and over \$1,500,000 in assets.
