Celebrating 50 years in operations, this business is a specialized geographic information systems (GIS) mapping, company located in Kansas City, Missouri. The Company serves more than 650 counties across 18 states, with a strong presence throughout the Midwest and South. Services include creating accurate, information-rich maps, production of county plat books, wall maps, digital mapping products, and parcel-data solutions. Its customers include county governments, Farm Bureaus, soil and water conservation districts, agricultural organizations, local advertisers, commercial businesses, landowners, farmers, and recreational property owners. Its experienced workforce consists of approximately 14 full-time employees, supported by 5 territory-based sales representatives. Key personnel include an Operations Manager, 5 GIS Specialists, design professionals, administrative staff, and printing and fulfillment support with 70% of the staff working remote. The owner provides oversight to the sales representatives, oversees hiring and HR, and handles payroll. Daily production, scheduling and staff accountability are managed by the operations manager. The owner is selling to retire and has offered to stay with the business for 1 year to transition the new owner into their role. Additionally, the seller has offered to carry 15% of the purchase price as a show of good faith in the continued success of the business post close.

Valued at **\$1,125,000**, this business is primed and ready for a new owner to step in and continue with a legacy that has been built over the past 50 years. They also provide GIS and digitization services, and performs printing, binding, fulfillment, and shipping in-house.
